## Method and Legal Reason of Collecting Personal Data

The marketing and advertising activities, which are performed by targeting and profiling methods, are applicable only upon your express consent. Your personal data collected may further be processed for the purposes stipulated hereunder within the scope of the conditions and objectives of personal data procession stipulated under the Articles 5 and 6 hereof.

### Parties to Whom Personal Data may be Transferred and Purpose

We, as Tav inşaat, may disclose your personal data under the Cookie Disclosure Text to our suppliers, legally authorized public institutions and private persons in limitation to achievement of above purposes and in accordance with the legislation.

### Which Cookies are Used and for What Purpose?

We, as Tav Inşaat, use cookies in our site and application for various purposes, and process your personal data by means of these cookies. These purposes are mainly as follows:

- To perform the basic functions that are necessary for the operation of the site and application.
  For instance, the members having opened sessions, shall not need to re-enter their passwords while visiting the differing pages in the Site.
- To analyze, and to increase the performance of the Site and the application. For instance; integration of the different servers over which the Site is operated, determining the number of the ones having visited the Site, making adjustments in its performance settings, or facilitating the search of its visitors.
